



Contribution Rules of the EduNet World Association e.V.

§1 Amount of contribution

Pursuant to §6 sentence 1 of the Articles of Association, the members of the Association shall contribute membership fees. The amount and due date of the membership fees as well as any further necessary details regarding the payment of the contribution shall be determined in accordance with §6 sentence 1 of the Articles of Association.

The General Meeting has adopted the following contribution rules:

1. The membership fees shall be charged as annual contribution.
 - a) In the case of companies, it shall be determined by reference to the net turnover generated by a member of the Association in the respective calendar year preceding the respective calendar year for which the annual contribution shall be paid (= net annual turnover). With a net annual turnover of up to EUR 100 million, the annual contribution shall be EUR 1.000,-. The annual contribution shall increase for each commenced amount of the net annual turnover of another EUR 100 million by EUR 1.000,- in each case. However, the annual contribution shall not exceed EUR 5.000,-.
 - b) In the case of associations of undertakings, the contribution shall be fixed at a flat rate of EUR 1.000,00 per calendar year.
 - c) Educational and research institutions, which are regarded as corporations of public law, shall be exempt from contributions.
2. If the admission to the Association takes place in the course of a calendar year, the full annual contribution pursuant to para 2 shall also be paid for the calendar year in which the admission takes place (= year of admission); ie, there is no pro rata temporis calculation of the annual contribution in the year of admission. In individual cases, the Board may agree with the new member on a reduction of the annual contribution for the year of admission. Decisive for determining the year of admission shall be the date on which the new member of the Association receives the Board's confirmation regarding the admission to the Association.
3. The amount of the annual contribution in accordance with the above-mentioned scale shall be determined annually by each member of the Association by way of selfassessment.

§2 Due date

1. The annual contribution pursuant to §1 of the contribution rules shall be due on July 1 of each year. If the admission to the Association takes place in the course of a calendar year, the annual contribution pursuant to §1 of the contribution rules shall be payable within two weeks after the member's receipt of the Board's confirmation regarding the admission to the Association, at the earliest, however, on July 1 of the year of admission.
2. The founding members of the Association shall pay their full annual contribution pursuant to para 2 for the calendar year 2017 on September 1, 2017 at the latest.

§3 Termination of membership

1. In the event of the legally effective exclusion of a member of the Association from the Association pursuant to §5 (3) of the Articles of Association, the excluded member of the Association shall be obliged to pay the annual contribution for the calendar year in which the Board's exclusion decision was taken if the exclusion decision was taken after the due date of the annual contribution has become effective pursuant to §2 of the contribution rules.
2. In all other cases of a possible termination of the membership during the year the contribution obligation shall remain unaffected. In particular, no reimbursement of contributions already paid shall be made on a pro-rata temporis basis.
